### All Right? Campaign Ready, Set, Go!

For the last couple of months the All Right? team have been busy planning the next steps of the campaign.

The next phase of All Right? will continue to build on the last six months, with a specific focus on three key themes:

- How are you doing today? We all experience different moods and feelings at different times. It's normal for our mood to change from day to day and even hour by hour.
- What things make you feel good? There are lots of things we can't control but you can influence the way you feel.
- 3. Who can you help today? Looking out for someone else makes you both feel good.

To help get the messages out there will be three periods of concerted advertising activity in September, February, and May. In September we will be using billboards, bus shelter adshels, and some pretty innovative newspaper advertisements.

On the research front, in October and November we will be undertaking our second survey looking at the wellbeing of Cantabrians. The results will help us paint a picture of where we are at as a region, how things have changed since our last survey which took place a year ago, and what impact All Right? has had on people's wellbeing. We plan to release the results early in 2014.
